**TERMS AND CONDITIONS OF CREDIT APPLICATION AGREEMENT**

**Credit Account Terms: (Net 30 days)**

Hereinafter, BLT Enterprises, Inc. is referred to as SELLER. The CUSTOMER, shown on page 1 of this application, is hereinafter called CUSTOMER. In consideration of the SELLER, selling to the CUSTOMER on open account the SELLER and CUSTOMER agree as follows:

1. Upon approval of this application, SELLER, in its sole discretion, will assign CUSTOMER a maximum credit line and shall have the right to increase, decrease, or terminate CUSTOMER'S credit privileges under this application at any time without prior notice to Applicant, except as otherwise provided by law.
2. CUSTOMER agrees to pay an additional 2% per month on all amounts over 30 days. Accounts that are past due will be subject to credit hold. If collections are necessary, the buyer agrees to pay all reasonable collection and legal or attorney fees. CUSTOMER hereby submits to the jurisdiction of the Courts of the State in which the Seller has its principal place of business, which state's laws shall govern this agreement.
3. Venue for any action hereon, by any of the parties hereto, or in connection herewith shall be in the County in which the Seller has its principal place of business.
4. This Agreement is not subject to oral cancellation or change. Any change to this Agreement must be in writing and signed by the parties.
5. All notices relative hereto must be in writing with proof of delivery by Registered Mail or Certified Mail, Return Receipt Requested and shall not take effect until received by SELLER. The rights provided for herein to SELLER are cumulative to all other rights SELLER may have though not provided for specifically herein.
6. The undersigned certifies that all statements in this Business Credit Application, and all of the documents included with the application are true and correct. SELLER is hereby authorized to obtain any confirming information from any source, concerning the statements in this application. (continued on page 3)

If executed by more than one, the obligations of the undersigned shall be joint and several and all references to the singular shall be deemed in the plural.
